Transit has agreed to provide transportation from the schools to our facility on a first come first serve basis. You will be making an agreement with them to transport your child from the school to our facility. We have received a grant from the David D and

Nona S Payne Foundation to pay for transportation. **We will not be charging a transportation fee for the 2019-2020 school year.**

We **will** need you to fill out either a Panhandle Transit Form (Travis, Austin and Wilson) or a Volunteer Transportation form (Lamar and PJHS).

The goal of Panhandle Transit is to provide safe, quality transportation to the student riders. To enable us to achieve this goal the following policy has been established.

WE ARE RESPONSIBLE FOR YOUR CHILD'S SAFETY. YOU ARE RESPONSIBLE FOR THEIR ACTIONS. WE WILL NOT TOLERATE ANY HORSE PLAY, OBSCENE LANGUAGE, GESTURES, FIGHTING, DISRESPECT OR DISCOURTESY TO OTHER PASSENGER OR OUR DRIVER, OR ANY ACTION THAT CAUSE THE DRIVER TO BE DISTRACTED FROM DRIVING SAFELY.

STUDENTS ARE REQUIRED TO WEAR SEAT BELTS AT ALL TIMES AND TO REMAIN SEATED WHILE THE BUS IS IN MOTION.

NO FOOD OR DRINK IS ALLOWED ON THE BUS.

ANYONE ENTERING THE BUS WITH A WEAPON OF ANY KIND, KNIVES, TOBACCO, DRUGS, OR ANY OTHER CONTROLLED SUBSTANCES WILL BE IMMEDIATELY AND PERMANENTLY SUSPENDED FROM RIDING THE TRANSIT.

DRIVERS ARE ALLOWED TO DROP OFF CHILDREN ONLY AT THE ADDRESS SPECIFIED ON THE MANIFEST. ANY CHANGES MUST BE SUBMITTED IN WRITTEN FORM WITH THE PARENT'S SIGNATURE TO THIS OFFICE AT LEAST ONE BUSINESS DAY PRIOR TO THE CHANGE.

YOUR CHILD IS NOT ALLOWED TO BRING A GUEST ON THE TRANSIT.

THE DRIVER HAS THE AUTHORITY TO DETERMINE REASON FOR SUSPENSION AND THE LENGTH OF SUSPENSION. NOTICE WILL BE GIVEN TO THE PARENT TO SIGN AND RETURN BEFORE CHILDREN WILL BE ALLOWED TO RETURN TO RIDING THE BUS.

PAYMENT FOR TRANSPORTATION IS DUE THE FIRST OF EACH MONTH.
